## 1. Eligibility Criteria

1.1 Life membership is awarded for significant and long-term service to the CWNC.

A life member must:

- Be over the age of 18.
- Be a currently active, financial with the club.
- Have always behaved in line with CW values.
- Have contributed in an exceptional manner to the club.

1.2 There is no prescriptive definition of exceptional contribution. Life membership can be based on a contribution of a wide variety of actions that constitute an exceptional contribution.

Contributions that may combine to constitute an exceptional contribution include, but are not exclusive:

- Playing 500 games or more for the club during the STNA Winter season (equates to over 10 years of playing)
- Holding an executive position with CWNC for 5 years or more
- Being a Committee member with CWNC for 10 years or more
- Demonstrated exceptional contribution in regards to administration of the club, (i.e. fundraising, team manager, supporting and other issues that the committee may see as relevant)
- Coaching for the club for 10 years or more
- Umpiring for the club for 10 years or more
- The nominee will have provided valued leadership and /or been an outstanding role model to the members in general.
- The nominee will have demonstrated a commitment to the principals of fair play and good sportsmanship.

The above criteria apply in whatever role the nominee has participated in during their service to CWNC, on or off the court. Achieving minimum service levels will not in any way automatically guarantee the award of life membership.

## 2. Nomination process

2.1 A potential life member must be nominated by a current senior member of the CWNC, the nomination must be seconded by a senior financial member of the CWNC. Self-nomination or nomination by an immediate family member is not permitted.

2.2 Nominations are to be completed on the Life Membership Nomination form. This form will be made available on the CWNC website, other socials and can be obtained from the Club secretary.

2.3 The nomination is to set out the achievements and activities of the nominee and meet the award criteria.

2.4 A completed nomination form should be given to the Vice President of the club who will arrange for distribution to the Life Member Committee.

2.5 Nominations must be received by 3<sup>rd</sup> September 2024 in the year which the nomination is to be considered. However, nomination can be made at any time leading up to this date.
